Application for Support – COVID-19 Cancellations

Classical singers are eligible to apply for up to \$500 in relief if they have lost income due to performances that have been cancelled because of COVID-19 public health concerns. Singers must be residents of New England. First round applications are due April 1; deadline may be extended as circumstances change. Applications are limited to singers who have lost income from cancelled classical music performances (opera, oratorio, symphonic, choral, recital, sacred—including church gigs); other public-health related cancellations are not currently covered by this emergency relief.
